President's Message

Hello my friends, it has been a most difficult task attempting to tie our reunion activities in with the other 60th anniversary celebrations that are being planned at D.C. during that week. In fact there are a few loose ends still pending that will be published in the June newsletter. Some of the particulars that were included in the supplement to the March newsletter sent previously are being duplicated in this newsletter to assure that everyone has the full details.

The official dates of our reunion this year are **July 21 – 28, 2013**. However, the special room rate will apply 3 days prior and after that date to accommodate those wishing to come early and stay late (see message page 5). As announced at Omaha last year, our hospitality room will not open until **Wednesday July 24th** this year and will remain open during the remainder of the entire event.

Our host hotel will be **The Doubletree Crystal City** located at 300 Army Navy Drive, Arlington, VA. For reservations call **(800) 222-8733 or (703) 416-4100 (direct)**. Ask for group rate of **\$109.00** plus 10% state and local tax. This is a **flat rate** compared in price to \$159.00 - \$169.00 at other hotels in the area.

The cut off date is **June 25, 2013**. After that date the rooms will be based on availability. To be assured of a room, it is critical that reservations be made at an early date due to the large crowd expected in D.C. at that time. You can always cancel if your plans change. A \$75.00 early check out fee will be charged, except in case of emergency.

A limited number of handicapped rooms with roll in showers are available. However, if a room with a toilet riser will suit your needs, save the fully handicapped for those who are more severely handicapped. Specify the type of room needed at the time of registration.

We visited the hotel and found it to be equal or superior to any hotel where we have met in the past, in cost, appearance and convenience, plus we received most all the requirements we requested.

The hotel is located within minutes of downtown Washington, D.C., Historic Alexander, Georgetown and the Pentagon. **Complimentary hotel shuttle service is provided to and from Ronald Regan**

Washington National Airport (DCA) The Crystal City Metro station, nearby shopping, restaurants and other attractions. The National Monuments, Government Agencies and Museums are accessible via the Metro, Metro stops runs every 30 minutes; the shuttle service to and from the hotel to the Pentagon Fashion Center and Pentagon City Metro stops runs every 30 minutes. As we are all aware, parking is at a premium anywhere in D.C. The normal hotel parking rate is \$20.00 per day. However, the hotel has discounted self-parking for our group to a low rate of **\$10.00 per day**. Valet parking is **\$29.00 per day**. For directions to the hotel we suggest you contact the Doubletree direct at **(703) 416-4100**.

Our banquet, which is usually planned for Saturday night, has always been the highlight of our event. This is the time we assemble together to fellowship, give thanks for our freedom, enjoy a delicious meal and recall the time such was only a dream. DPMO report

Hi! I've often been asked, "how many men were Prisoners of War (POWs) during the Korean War?" I don't know exactly, and this story is worth telling. Government figures are quite good, and the number most often seen is 7140. It takes in 2701 men who died as POWs, 4418 who returned alive, and 21 who refused to come home. Those who came back alive include Little Switch and Big Switch, near the end of the war, and quite a few who escaped from forward areas. But our friend, CSM Tim Casey, has discovered well over 5200 survivor names. This number includes quite a few others who were cut off by enemy forces, then escaped after a few days. Many simply returned to their units.

National Archives has a list of 4447 returning POWs, but it also misses many of these short-termers. There was also a problem with POW deaths in South Korea. Massive battles around Hoengsong in February 1951 give us an example. Whole battalions were encircled, with many men captured. They were gathered up and held locally before marching northward by night. Some died along the wayside or in villages where the groups of 50 to 100 were held by day. After the lower ends of these tracks were retaken by friendly forces, graves registration work picked up, on both battlefields and routes. When remains of men reported as POWs were found and identified, they were returned to their families as POWs.

But sometimes missing men who died along the wayside were simply tagged as killed in action. We've found cases in which the bodies of men lost, especially in February-May 1951, were 10 or 20 or even 50 miles from their battle zones, typically farther north. Very obviously, they had marched northward as POWs. Left behind in villages, names were often forgotten by those who went on. Yet when bodies were found and identified, it was very obvious that some had been short-term POWs.

We handle things very differently today. Most of the human remains turned over by the North Koreans in 1990-94 and 2007 are men known to have died there, but a few were MIA from South Korea where they were last seen alive. We've taken special care to inform families whenever these men are identified. There are other examples, as well. Our recovery teams worked at both the Unsan and Chosin Reservoir battle zones. But some of our recoveries (and some of the North Korean turnovers) have been from north of the fighting areas. More identifications have followed, and where the remains themselves provide evidence of captivity, we've told the families. So how many men were captured? Counting men in all the different categories, as many as 7900. As time moves along, we'll try to make that more exact. Best to all! Phil O'Brien

REMAINS IDENTIFIED AND RETURNED.

After 62 years, PFC Glenn Schoenmann is finally Home,January 10,2013. PFC Schoenmann, served with Company M, 3rd Battalion, 31st Infantry Regiment, 7th Infantry Division, was captured on November 28, 1950,

and died while a prisoner on December 29, 1950. His remains were reportedly recovered in 1954, but the identification process was finalized in December 2012 by using DNA from his family. He is survived by his sister, Edna Kilgore of Monteagle; brothers, Ernest Schoenmann of Creve Courc of Illinois, Raymond Schoenmann of Tracy City, and Carl Schoenmann of Winchester, sister-in-law, Joyce Schoenmann, of Gallatin, TN, several nieces and nephews and a host of cousins. William (Bill) Norwood attended the Memorial Service on January 10, 2013.

Pfc. Weldon Alonzo Davis (B Battery of the 38th Field Artillery Battalion, 2nd Infantry Division) is scheduled to come home to North Texas, 62 years after he died in a Korean prisoner of war camp. Davis will be buried with military honors at 1:30 p.m. Wednesday in Dallas-Fort Worth National Cemetery.

Son of a Korean War POW Volunteers at Andersonville by *Eric Leonard, Chief of Interpretation and Education*

Volunteers provide critical assistance to the operation of the park. In the past year, a number of volunteers have stayed in the park for one to three months and worked in the National Prisoner of War Museum, greeting visitors and leading programs. All of these volunteers are drawn to this place to help us tell the prisoner of war story to the visiting public; this fall, we were joined by a volunteer who had another reason to volunteer here – his father had been held as a prisoner of war in Korea for 33 months.

Pat and Diana Curry, of Lubbock, Texas, joined us in mid-September. They had arranged to volunteer here a year earlier, and we had discussed at that time Pat's interest in volunteering at the museum. Pat was drawn to the park as a way to learn more about his father's experiences in Korea. My first assignment to them was to spend a day being visitors, exploring the entire park, in order to get to know all that the park offers.

While taking in the museum's exhibits the next day, they discovered something that none of us expected – as it turns out, the video loop in the *Freedom* room, which shows news footage of returning POWs from WWII through the First Gulf War, includes a brief shot of Pat's parents embracing, when his father, Lt. Jim Curry, returned home in 1953. Also in the picture is Pat, at age seven.

This unexpected moment more than exceeded Pat's hopes for his volunteer experience here, and was a good start to two months of volunteering.
