Korean War POW/MIA Report (JPAC) (Item has bold face within, please use in HTML format) Dear Friends. Let's do a little more bird's eye map work! You'll need a home computer, or your local public library. Use **Google Maps**, in **satellite mode**. You can drop down on the locations you pick, almost anywhere on Earth. Don't worry, the librarian can explain "how to," if need be. In the little story that follows, you'll see map references, like **125 26 00 E, 40 37 30 N**. They are in East longitude and North latitude. They are pretty exact, down to a hundred feet or so. Just read them as they are, including spaces and the comma. When you are ready, punch them in. As soon as the map image shows on your screen, you can zoom in, zoom in, zoom in, down to helicopter level. Last time, we spoke briefly of the 8th Cavalry's action at Unsan on 2-5 November 1950, and the route that POWs from this battle took northward to the holding village of Sambakkol, then on to Camp 5. Let's turn now to the major battles fought along the Chongchon River, at Kujang, Kunu-ri, and Ipsok, about three weeks later, from just after Thanksgiving Day. Thanksgiving came a bit early in 1950, on Thursday, 23 November. In the days that followed, 2nd Infantry Division was heavily engaged around Kujang, working south to Kunu-ri. Farther west, 25th Infantry Division was hit almost as hard as it fell back from Ipsok.

Our main concern is in what happened to the many men who were captured during this battle. Fighting continued through 2 December, so men were taken on different days and held locally throughout the battle zone. Some men from 2nd Division remember caves used by the Chinese near Won-ni, above Kunu-ri near **125 57 51E, 39 46 54 N**. The area has changed quite a bit. The extended town of Sambong-dong, just north, was little more than a cluster of huts at the time. The caves are scattered around the hillsides, mainly just east. Other men were held near a narrow pass now known as "The Gauntlet," where 2nd Division tried to break through to Sunchon, farther south. There is a new, larger reservoir in the area, and the old road has been rerouted. But the bend near the southern end of the ambush zone is still visible, and this is also an area where men were held for a short time. Go just east of Karhyong-dong to **125 52 37 E, 39 35 06 N**. This is where the lower end of the old road and new road come back together. Men moved in groups of 50 to 100, usually night by night, and finally collected at the Pukchin-Tarigol Mining Camp, known to many as Death Valley. The old Japanese mines had been worked along the western side of the valley for years, and as tunnels played out, new ones were dug farther north and farther east. So the little miners' villages kept moving, and now they have expanded into a major industrial town. The main cluster used by our POWs was near the foot of the valley, where a narrow gauge railway went farther up, to the ore processor, and where the old main road turned back out of the valley, at **125 44 51 E, 40 12 04 N**. At first, there were two main POW hut clusters in the valley. One was here, and the other was about a half mile farther north. Many of the men arrived at Pukchin-Tarigol on Christmas Eve or on Christmas Day 1950. But some men had died en route, at villages or along the wayside. When our joint recovery teams were working at the Unsan battle zone in 2002 and 2004, they were allowed to visit an isolated valley several miles north of the battle zone where they made several recoveries. Four men, all POWs intent on Pukchin-Tarigol, have now been identified from the area around **125 46 30 E, 40 02 30 N**. The Chinese knew that men were dying at Pukchin-Tarigol, and wanted to get as many as they could out of the area and up to their main, permanent camps on the south bank of the Yalu River. Camp 5, at Old Pyoktong, would be the first. Those men who could march out from Pukchin-Tarigol left in a large group, around 21 January 1951. They needed about seven days to reach Camp 5. A second movement, using ox carts and carrying the last of the survivors, began around 13 March 1951, and it arrived about six days later. Camp 5 at Old Pyoktong, now known as Tongju-ri, has changed very little since 1953. Mud huts are now cinder block. There is a little paving and a little gravel. But you can still see outlines of the old village, centered at **125 26 00 E, 40 37 30 N**. More will follow, for different groups of men, as we go along. Best of thanks! Phil O'B

Korean War MIA Identified: The Defense POW/Missing Personnel Office announced the identification of remains belonging to Air Force 1st Lt. Robert F. Dees, 23, of Moultrie, Ga. On Oct. 9, 1952, Dees was piloting an F-84 Thunder jet against enemy railcars near Sinyang, North Korea. All contact was lost with him after an explosion near the target was observed by other flight members. In 1954, North Korea turned over remains reportedly recovered from Sinyang, but Army mortuary affairs was unable to identify the remains, which were subsequently buried as "unknown" in the National Cemetery of the Pacific in Honolulu. Tour Descriptions

NORFOLK CITY TOUR/ MACARTHUR MEMORIAL

Wednesday, August 3: Begin the day with a driving tour of Norfolk. Drive by Moses Myers House, where one of America's first millionaires lived; the Willoughby-Baylor House, built in 1794 and representative of both Georgian and Federal architecture; and St. Paul's Church, built in 1739 and the lone survivor of the British bombardment and fiery destruction of the city by Lord Dunmore in 1776. A British cannonball is still embedded in the southeastern wall of the church. Continue on to the MacArthur Memorial, featuring an eleven-gallery museum and the final resting place of the late general. Visit the gift shop and/or see a film summarizing the general's life and achievements. Lunch will be at the MacArthur Center Mall, a downtown shopping mall with lovely shops, many restaurants, and a food court. Don't forget Nordstrom has a café on the third floor!

NAVY BASE / NAUTICUS

Thursday, August 4: Tour the Norfolk Naval Base, the world's largest naval facility. Pick up your guide at the Naval Base Visitor Center and continue on a driving tour of Admiral's Row, the Naval Air Station, and the piers. Enjoy lunch at one of the Clubs on base, featuring a chicken salad croissant. After lunch, head downtown to Nauticus, an exciting 120,000 square-foot science and technology center that explores the power of the sea with interactive and educational exhibits. On the second deck of Nauticus is the Hampton Roads Naval Museum, which features a large collection of naval artwork, ship models and underwater artifacts. Also part of Nauticus is the USS Wisconsin. The Wisconsin is one of the largest and last battleships to be built by the U.S. Navy. Note: If for any reason the Naval Base is closed to the public (i.e: security issues), the tour length will be shortened, but refunds can't be issued. Due to heightened security, participants may be searched and a photo ID is required.

VIRGINIA AQUARIUM

Friday, August 5: Spend the day at the Virginia Aquarium. Upon arrival, enjoy nearly 100 participatory exhibits, including a weather room where you can create waves or start a storm. Hands-on exhibits include a touch tank where you can hold a sea star, see a hermit crab's home, or pet a horseshoe crab. This museum recently tripled in size, adding over 500,000 gallons of aquariums. New exhibits the Norfolk Canyon Aquarium, featuring sharks and other large ocean dwellers, a 70,000-gallon sea turtle aquarium, a river otter habitat, and an outdoor aviary. Watch the resident decoy carver practice his craft, or walk a boardwalk through a salt marsh. For a nominal fee enjoy an IMAX presentation. This spectacular facility wraps you in a hyper sensory experience while you view the multi-story screen. Through special technology IMAX gives you the feeling of being in the picture, so you can experience every scene, every motion with eye-opening clarity. Lunch on your own in the Osprey Café, which offers a variety of soups, salads, and sandwiches, along with daily specials.
