## **Korean War POW/MIA Report (JPAC)**

We've explored many ideas with these little notes; now let's try something new, real bird's eye exploring. To do this, you'll need a home computer, or access to one at your local public library. Use Google Maps, in satellite mode. You can drop down on the locations you pick, almost anywhere on Earth. Don't worry, the librarian can explain "how to," if need be. This is a public technology, and we use it often. In the little story that follows, you'll see map references, like 127 02 26 E, 37 11 56 N. They are in East longitude and North latitude. They are pretty exact, down to a few hundred feet or so. Just read them as they are, including spaces and the comma. When you are ready, punch them in. As soon as the map image shows on your screen, you can zoom in or zoom out, as you wish.

Not making light, these were terrible times for the men involved, but at least we can see a little more, and possibly understand a little more. Let's start with the first gathering of Korean War POWs, "Tiger Group." Men from 21st Infantry were captured as early as 5 July 1950, between Suwon and Osan in South Korea. First battle of the Korean War: road and rail lines between two low hills, which they tried to hold, are still there, but you'd have a hard time recognizing the area. Have a peek, punch in 127 02 26 E, 37 11 56 N. That's all you need to do.

These early fighting men from the 24th Infantry Division fell back as they fought, defending Taejon and its critical airport until overrun on 20 July. Then, Taejon was a town, today it is a city. Some of you might remember the main train station. It's been rebuilt, and the area around it has a good share of high-rise buildings. Have a peek, punch in 127 25 56 E, 36 19 56 N.

Many men were captured. The POWs who became Tiger Group marched north and gathered at Seoul in July and August 1950. Next, they were in Pyongyang, leaving by train in early September to arrive at Manpo a few days later. Tiger Group did not stay in Manpo for long. This was also an entry point for Chinese troops coming into the Korean War. Best to all! Phil O'B

## **.U.S. Soldier MIA from Korean War Is Identified**

The Department of Defense POW/Missing Personnel Office announced today that the remains of a U.S. serviceman, missing in action from the Korean War, have been identified and returned to his family for burial with full military honors.

U.S. Army Cpl. Stanley P. Arendt was buried on March 29 in Palatine, Ill. In early November 1950, Arendt was assigned to the 8th Cavalry Regiment, 1st Cavalry Division occupying a defensive position near the town of Unsan in the bend of the Kuryong River known as the "Camel's Head." Arendt's unit was involved in heavy fighting which devolved into hand-to-hand combat around their command post. Almost 400 men of the 8th Cavalry Regiment were reported missing in action or killed in action from the battle at Unsan.

In May 2004, a joint U.S.-North Korean team excavated a mass grave near the "Camel's Head" after receiving a report that an elderly North Korean national had witnessed the death of seven or eight U.S. soldiers near that location and provided the team with a general description of the burial site.

The excavation team recovered human remains and other personal artifacts, ultimately leading to the identification of seven soldiers from that site. Among the forensic techniques used in the identifications by the Joint POW/MIA Accounting Command was that of mitochondrial DNA, five samples of which matched the DNA of Arendt's brother.

**CITY TOUR**

**Wednesday, August 4**

Begin your driving tour of Chicago with some of its most well-known landmarks. Take in Wrigley Field, Lincoln Park, Lake Shore Drive, the Chicago Board of Trade, and the famous "Loop," Chicago's Financial District.
