There are various reasons for taking this action. The loss of membership due to age and deaths, inability to travel, the task of maintaining the membership roster, formulating, producing and distributing the newsletter, lack of those willing to serve in leadership positions and the tedious and difficult task of preparing and submitting required legal documents associated with the Corporation. Dissolving the Corporation does not mean that a reunion arranged under a different title can not be planned, if there is an interest and there are those who are willing to take on this task. If there is anyone who would like to pursue this matter I suggest they form a committee and formulate a plan to be presented at the reunion in Louisville. It has been a good ride for 39 years but for the reasons stated above, along with many others, the Corporation known as The Korean War EX-POW Association will come to a close in 2015.

FATHER KAPAUN

So much has been written about Father Kapaun. I'd like to add a few thoughts of my own. When he arrived with the 8th Cavalry in July 1950, North Korean forces were still advancing and the Naktong Perimeter was yet to be formed. He was up with his men, and as friendly lines continued to fall back, he was usually almost as close to the enemy. He didn't speak of it, but one concern was surely capture. It was not a question of himself, but of the men with him.

He knew what had happened with Capt Herman G. Felhoelter, a few weeks before. Also a Catholic Chaplain, he chose to stay behind with about 30 wounded men of 24th Division just north of Taejon. He ordered every man who could still walk to move out. Father Felhoelter did what he could, physically and spiritually, until they were overtaken and killed in what later became known as Korean War Crimes Case #10.

A few months later, Father Kapaun found himself in a very similar situation at Unsan, North Korea, as the 3rd Battalion Command Post, 8th Cavalry, was overrun by Chinese forces. But there were two critical differences. He and other officers could arrange an orderly surrender, and the Chinese troops involved were under disciplined control. His final act there, to pick up a wounded man and carry him to safety, set the tone for the others as well. Some would die, here and there, but there would be no massacre.

En route north to Sambakkol and Camp 5, Father Kapaun met the captured 19th Infantry Chaplain, Capt Kenneth C. Hyslop, and a Northern Baptist. While trying to minister to his men, Pastor Hyslop had been kicked and clubbed by guards. The internal injuries were mortal and he died a few days later at Sambakkol. But the two Chaplains had a chance to talk, and Father Kapaun realized that his service from this point would have to be more careful. He still went out at night. He found food and heated water. He shared all that he could, and pressed other to do the same. But he would be watchful, even while trusting God. To die today would help no one tomorrow.

His service would have to be urgent but measured, until it consumed the last bit of his energy and livelihood at Camp 5. When Faher Kapaun finally passed at the Old Pagoda death house, he knew that he had done all that he could, all that God would allow. He had learned from Father Felhoelter and Pastor Hyslop, and then joined them on his final day.

BAFS, Carl, **J.** died on August 16, 2013. Bafs served with Med Company, 7 Cav. 1st Cal. Div., was captured on December 2, 1950 and returned during Big Switch, on August 17, 1953.

It was 40 degrees below zero on Nov. 29, 1950 and the American Soldiers were surrounded by Chinese. The location was 40 miles northwest of Pyongyang. It was the battle of Sonchonni and Bafs was captured. Thirty one prisoners began the 300 mile march to Anju, but 19 froze to death or died from diarrhea; Sgt. Bafs was one who made it. From Anju to Chang Song (Camp 1 and 3) he remained until August 1953.

BAKER, William E. passed away June 5, 2013 as reported by his wife. He served with Svc. Btry. 38th FA BN, 2Div. He was captured on Nov 30, 1950 and returned during Big Switch on August 28, 1953. Camps 5 & 3.

CHANCE 'Inky '(Adelbert) W. was promoted to Glory on August 27, 2013 in Newfield, New Jersey due to late stages of Parkinson's disease. He was stationed in Fukuoka, Japan on Occupation Duty with A Battery, 63rd Field Artillery of the 24th Infantry Division, and deployed with that unit to Korea in early July 1950. He was a PFC and a scout and promoted to Corporal after capture. Inky was captured on July 14, 1950 during the Kum River engagement. He was released on August 23, 1950. Lois, the love of his life, preceded him to heaven.

I remember Inky and one day he could not stand against the force of the wind. He said repeatedly, "I am not going to die in this ungodly place". I never saw anyone fight for life like Inky Chance did. Shorty Estabrook, B/19/24 Prisoner of War with Inky


