from Franklin "Jack" Chapman

I want to thank all of you wonderful people who helped to make our 29th Reunion at the San Antonio Omni Hotel a huge success. We had an excellent turn out considering Hurricane Katrina which caused several of our families and friends to cancel their reservations.

#### Tibor Rubin Awarded the Medal of Honor

Rubin was first incarcerated at age 13 during World War II. He was forced from his Hungarian Jewish community to a concentration camp in Austria. Both parents and his two sisters perished in the Holocaust. Rubin survived until the camp was liberated two years later by American troops. Being liberated by the U.S. Army, Tibor felt that if he ever made it to the United States of America, he would join the Army.

Rubin immigrated to the United States in 1948 and answered the call to duty by volunteering for Army service. During numerous battles in Korea, Rubin's actions with the 1<sup>st</sup> Cavalry Division, engaging the enemy and tending to the wounded, were what officials described as "careless disregard for his own safety." In one such battle, Rubin single-handedly defended a hill, manning a machine gun for 24 hours, throughout the night and next morning, allowing the 8<sup>th</sup> Cavalry Regiment to successfully withdraw.

Ruben was severely wounded before being captured along with other soldiers. On November 2, 1950, Chinese troops captured Cpl. Rubin and other soldiers and he became a prisoner of war. For the next two and half years, Rubin risked his life daily to keep his fellow soldiers alive. He was nominated four times for the Medal, the nation's highest recognition for bravery in battle. On September 23, 2005, in Washington D.C., President Bush presented Rubin the Medal of Honor.

Congratulations, it is about time!

## Korean War MIA Remains Identified

July 21, 2005, the Department of Defense POW/MIA Personnel Office (DPMO) announced that remains of a U.S. serviceman, missing in action from the Korean War, have been identified and are being returned to his family for burial with full military honors. He is Cpl. Leslie R. Heath, of Bridgeport, Illinois. His interment was scheduled for August 20 in Bridgeport.

On the morning of April 23, 1951, Heath and more than 80 members of the A Company, 1<sup>st</sup> Battalion, 5<sup>th</sup> RCT were captured by the Chinese Communist forces. They were held in a temporary POW camp known as Suan Camp Complex, in the North Hwanghae Province, North Korea. A former American POW who was returned to the U.S. through Operation Little Switch recounted that Heath died in June 1951 while imprisoned.

On May 24, 2005, the Defense POW/MIA Personnel Office announced that specialists from the Joint POW/MIA Accounting Command (JPAC) came out of North Korea with an unknown number of remains of US servicemen lost in two major battles during November-December 1950. Two of the remains have been identified. One was identified as Cpl. John O. Strom, of Fergus Falls, Minnesota, a member of the 1<sup>st</sup> Battalion, 8<sup>th</sup> Cavalry, I Cavalry Division, who was reported missing in the early days of November 1950 near Unsan.

The second set was identified as PFC Lowell W. Bellar of Gray, Indiana, a member of Company M, 31<sup>st</sup> Infantry Regiment, 7<sup>th</sup> Infantry Division, who was killed on December 1, 1950, near Hagaru-ri. PFC Bellar was buried on July 15, the date of his birth in 1931.

#### National POW/MIA Recognation Day

Patrick Quinn and Ray Unger attended the National POW/MIA Recognition at the Jesse Brown VA Medical Center in Chicago on September 16, 2005. They were the only Korean POW's in attendance and were invited to detail their experience, which they shared.

#### Distinguished Service Cross

PFC Florentino Gonzales was awarded the Distinguished Service Cross for extraordinary heroism in action while serving with Company B, 21<sup>st</sup> Infantry Regiment, 24<sup>th</sup> Infantry Division, on July 5, 1950, near Chonan, Korea.

During an enemy attack which had been in progress for seven against overwhelming hours odds, his unit was ordered to withdraw as their ammunition was almost depleted. With no regard for his own personal safety, he volunteered to stay at his position and continue to fire his machine-gun to cover the withdrawal of his unit and to protect his assistant machinegunner, who had been seriously wounded. Undaunted, he continued to deliver effective fire on the enemy, inflicting heavy casualties.

He was last seen when his position was overrun by the enemy. Congratulations.

# **POW Trivia**

Do you know this POW?

On April 24, 1951, he fought off waves of attacking Communist Chinese troops on an anonymous jagged mountain during the war. While he was a Corporal and squad leader in the 3<sup>rd</sup> Infantry Division, his men were required to hold a defensive position while Allied units withdrew from overwhelming enemy force. After ordering his men to safety while he staved off the waves of enemy troops killing 50 with his machine gun and bayonet, he was eventually wounded and captured.

On Thursday, August 20, 1953, this POW was released at Freedom Village along with 59 other prisoners of war (including yours truly). On Friday, August 21, 1953, we left the Port of Inchon on the Marine Adder.

On board was this POW who upon being released, learned that he had been awarded his nations' highest award, the Congressional Medal of Honor. There was no band, no ceremony as he was told that he had been awarded the Medal of Honor. His winning of the Medal of Honor had borne a classification of secret until his release. On Saturday, September 5, 1953, the Navy Transport Marine Adder sailed under the Golden Gate Bridge for the Port of Embarkation, Fort Mason, Ca; with 367 repatriated prisoners of war including the Medal of Honor Winner.
